PPS x AlipayHK Binding HK\$20 Reward Terms and Conditions

- 1. The promotion of "PPS x AlipayHK Binding HK\$20 Reward" (the "**Promotion**") commences from 12th November 2023 to 31st December 2023 (Hong Kong Time) (the "**Promotion Period**").
- 2. During the Promotion Period, the first 10,000 new users (refer to users that have not bind PPS and AlipayHK mobile application in past 12 months) who successfully bind PPS and AlipayHK mobile application ("AlipayHK App") ("Eligible Users"), can receive a HK\$20 e-Reward ("Coupon"). Eligible users with a single net spending of HK\$220 or above at Taobao platform (through the Taobao mobile application only) using PPS via AlipayHK App will enjoy a HK\$20 instant discount.
