

## “PPS App x CLP App HK\$20 Yata e-coupon” Terms & Conditions

1. “PPS App x CLP App HK\$20 Yata e-coupon” (the “Promotion”) commences on 15 December 2025 and ends on 15 March 2026 (the “Promotion Period”).
2. The Promotion is only eligible for users (“Eligible Customers”) who register for the Promotion and successfully make their CLP Power Hong Kong Limited (“CLP”) bill payment by PPS via CLP App within the Promotion Period. Users who were awarded the HK\$20 Fairwood coupon in “PPS App x CLP App HK\$20 Fairwood e-coupon” promotion from 1 November 2024 to 30 June 2025 are not eligible to participate in the Promotion. The eligibility of users shall be determined by the computer records held by EPS Company (Hong Kong) Limited (“the Company”) and CLP Power Hong Kong Limited.
3. During the Promotion Period, users who opt to pay their CLP bill by PPS via the CLP App will be prompted to register for the Promotion before making the CLP bill payment. As part of the Promotion registration process, users will be required to provide (1) their CLP account number and (2) a unique mobile number. This mobile number will be used to receive the QR code via MMS for the HK\$20 Yata Limited (“Yata”) e-coupon, if the user is deemed an Eligible Winner. Users are responsible for ensuring the accuracy of the mobile number provided, confirming that the mobile number has sufficient mobile data, and can receive MMS messages. If more than one registration is completed under the same CLP account number, only the first submission will be eligible for the Promotion.
4. Each PPS account will be entitled to only 1 time of reward during the promotion period.
5. Users who fail to register for the Promotion during the Promotion Period are not eligible to participate in the Promotion.
6. The Promotion is limited to the first 2,000 Eligible Customers who successfully complete their first CLP bill payment by PPS via CLP App, along with a successful Promotion registration (“Eligible Winners”). The total quota of the HK\$20 Yata e-coupon (“E-coupon”) for the Promotion is 2,000, on a first-come, first-served basis, while stocks last. The computer record of the Company shall prevail under any circumstances.
7. Eligible Winners will receive the E-coupon via MMS. Each Eligible Winner (based on CLP account number) will be entitled to a maximum of one (1) E-coupon during the Promotion Period.
8. Eligible Winners must not cancel their PPS account, debit bank account associated with the PPS account, and /or the CLP bill payment(s) made under the Promotion before the release of the E-coupon.
9. E-coupon will be sent to the Eligible Winners by MMS via the mobile number provided at the time of the Promotion registration within 8 weeks after the successful registration. The Company will post the announcement at [ppshk.com](http://ppshk.com) on or before 14 May 2026. Please contact PPS Promotion Hotline at 2721 0373 on or before 14 June 2026 if no E-coupon has been received after the announcement.
10. The E-coupon is valid for 6 months from the date of issue, Eligible Winners are required to redeem the E-coupon before expiry date and PPS would not reissue the E-coupon if expired. An expired, unused E-coupon will not be reissued, extended nor refunded.

11. The E-coupon is worth HK\$20 and can be used for any regular priced items at any Yata branches in the Hong Kong Special Administrative Region.
12. The E-coupon and/or QR code can be redeemed once only.
13. The E-coupon can be used in all Yata branches in Hong Kong.
14. The E-coupon must be presented before payment.
15. The E-coupon cannot be exchanged for cash, other goods, discounts and is not allowed for resale by any means.
16. The E-coupon cannot be used in conjunction with any other promotional offers, e-coupons, cash coupons, staff offers or credit card promotions.
17. When consumption exceeds the E-coupon value, the excess amount must be settled by the consumer. No refund will be made by Yata if the consumption is below the value of the E-coupon.
18. Provision of the information by the user during the registration process represents that the user agrees and understands the purpose of the information collected, and constitutes an acceptance of all terms and conditions in this promotion.
19. EPS Company (Hong Kong) Limited, CLP Power Hong Kong Limited and Yata Limited have no liability and will not re-issue the E-coupon if it is stolen or lost.
20. Yata Limited reserves the right to amend the terms and conditions of this E-coupon without prior-notice. Yata Limited reserves the right of the final decision in case of any disputes.
21. Any transactions involved in a refund request and/ or are found to be fraudulent or any bill(s) which are cancelled or refunded ultimately, are all excluded from the Promotion.
22. The Company will verify the relevant payment information against the Company's computer records, which shall be final and conclusive. All matters and disputes are subject to the final decision of EPS Company (Hong Kong) Limited, CLP Power Hong Kong Limited and Yata Limited.
23. All employees of the Company and their family members are not eligible to the Promotion.
24. The promotion is only valid in Hong Kong SAR and applicable for Hong Kong users.
25. In case of any discrepancies or inconsistencies between the Chinese and English versions on the Promotion terms and conditions, the English version shall apply and prevail.
